Although my journey to obtaining an amateur radio license faced numerous delays due to life's demands and my career commitments, I finally achieved this milestone in 2020 and obtained my technician, and General license, and I further advanced by passing the Extra exam in March 2021.

Drawing from my extensive experience in law enforcement and emergency services, I learned a wealth of knowledge in various radio communication technologies. This helped to prepare me for being an amateur radio operator.


Beyond amateur radio, I actively contribute to several organizations, including HamSCI Ham Radio Science Citizen Investigation (HamSCI.org). My fascination with space traces back to my upbringing in Florida, where I frequently visited the Kennedy Space Center and witnessed numerous awe-inspiring launches. Additionally, I am an avid stargazer, always eager to explore the mysteries of the cosmos.

I was a member of the Civil Air Patrol/USAF Auxiliary, where I served as a senior member/2nd Lt., fulfilling roles as a public affairs officer and safety officer for composite squadrons at MacDill AFB in Tampa and later at Charleston AFB in South Carolina. I also dedicated 17 years as a Sangaree Special Tax District Commissioner in Summerville, South Carolina, resigning as Chairman in 2017 upon relocating to Berea, Kentucky, where my wife and I now reside. Since 2018, I have been actively volunteering at my local sheriff's office, providing assistance whenever needed.

I am a member of Amateur Radio Relay League, Central Kentucky Amateur Radio Society (CKARS.org), The Radio Amateur Satellite Corp (AMSAT), OM International Sideband Society

(OMISS.net), Kentucky Contest Group (KCG), and Kentucky ARES, I hold various roles, including W5YI-VEC Volunteer "Local in Person Only" Examiner, ARRL Volunteer Examiner, ARRL Registered License Instructor, and a longtime National Weather Service (NWS) Certified SkyWarn Spotter with NWS chat privileges on Slack."
